# **CONDITIONS OF COMPETITION**

Unless the penalty is otherwise noted, the NGAP Tournament Committee reserves the right to determine the penalty for a breach of the condition.

**OPEN** to all local and foreign amateur golfers with certified handicap index.

- 1. The 5<sup>th</sup> National Doubles Amateur Golf Championship shall be managed by a COMMITTEE.
- 2. **Rules of Play** all play shall be in accordance with the Rules of Golf as approved by the R&A, Conditions of Competition, addendums and the Local Rules of Camp Aguinaldo Golf Club.
- 3. **Entry Fee:** P2,500.00 per participant (if member of NGAP Clubs) P3,500.00 for Foreign Entry

Deadline of Entries/Entry Fee: On or before December 23, 2015 (Wednesday 12:00PM).

4. **Teams.** The field shall be composed of the following: Teams may be composed of partners of male/male, male/female and female/female based on the following criteria:

# Group I

- Teams with a member of the National Team for the years 2013, 2014 and 2015 (Putra Cup, SEA Games, Asian Games, World Amateur and Nomura Cup). No team will be composed of 2 National team member for 2013, 2014 and 2015.
- Teams with both players having an index of 4.0 or less.
- Maximum of 16 teams will be accepted

#### Group II

- Teams composed of players both with index of 4.1 and above.
- Maximum of 16 teams will be accepted

## Group III

- Teams composed of players 30 years and above as of Dec. 27, 2015 regardless of handicap index.
- Maximum of 16 teams will be accepted

Note: Men will tee-off from the blue tee and ladies from the white tee.

- 5. The Championship shall be decided by stroke play over three rounds each subject to the Committee's right in the event of conditions or circumstances which make the playing of three rounds impracticable, to cancel any round.
  - 1<sup>st</sup> day (Dec.27, 2015) Four-ball (Best ball). During the stipulated round, each partner plays his own ball. The lower score of the partners is the score for the hole.
  - 2<sup>nd</sup> day (Dec. 28, 2015) –. Aggregate. During the stipulated round, each partner plays his own ball with the total score of the partners as the score of the day.

• 3<sup>rd</sup> day (Dec. 29, 2015) – Two ball foursome. During the stipulated round the partners must play alternately from the teeing grounds and alternately during the play of each hole. Penalty strokes do not affect the order of play.

#### 6. **PRIZES** will be awarded as follows:

- Over-all champion the team with the lowest three day score will be declared champion regardless of which group they played.
- Champion and Runner-up for each group.
- 7. In the event of tie/s for 1<sup>st</sup> place, ties will be broken via sudden death play-off with the format (two-ball, four ball or aggregate) to be drawn prior to the sudden death play-off.
  - 7A. Ties for 2<sup>nd</sup> and 3<sup>rd</sup> place will be decided via count back last 9 holes, last 18 holes, last 27 holes and last 36 holes respectively.
- 8. Starting times and pairings. Play shall be in groups as determined by the COMMITTEE. The draw for the 1<sup>st</sup> round will be made by the COMMITTEE. Draw for the 2<sup>nd</sup> and 3<sup>rd</sup> day will be arranged according the team's score; the lowest score will tee off last.

# 9. **DECISIONS**

- The Tournament Referee's decision is final. (Rule 34-2)
- The decision of the COMMITTEE shall be final. (Rule 34-2)

### **DISTANCE MEASURING DEVICE**

A player may obtain distance information by using a device that measures distance only. If during a stipulated round, a player uses a distance measuring device that is designed to measure other conditions that might affect his play (gradient, wind speed, temperature, etc.) the player is in breach of Rule 14-3, for which the penalty is disqualification, regardless of whether any such action is actually used.

#### **COMMITTEE**

The Tournament Committee reserves the right to change any of the conditions of play, to fix and/or alter the starting times of a flight at any time for the best interest of the Championship.
