

# 4th MVPSF Visayas Regional Golf Championship Cebu Country Club April 8-12, 2019

# **TERMS OF COMPETITION**

## GENERAL

a. The 4<sup>th</sup> MVPSF Visayas Regional Championship (Match Play) (herein known as 'Championship' will be played at Cebu Country Club from April 8-12, 2019 in accordance with the Rules of Golf (effective January 2019) as approved by the R&A Rules Limited and with the Local Rules approved by the OC.

## ELIGIBILITY

*Men's Division:* Only the first 44 men amateur golfers with certified handicap index of 9.7 and below will be accepted. In case there are more than 44 entries, the 44 with the lowest handicap index will be accepted.

*Ladies Division:* Only the first 20 lady amateur golfers with certified handicap index of 10 and below will be accepted. In case there are more than 20 female entries, the 20 with the lowest handicap index will be accepted.

*Mid-Amateur Open Division:* Players with a maximum UNHS Handicap of 18 are eligible to play. The Mid-Am Open division shall be Gross play. They shall play **36 holes** (Stroke Play) on April 11 & 12. Limited slots available.

The handicap index reference will be March 2019.

The Committee reserves the right to refuse any entry without giving any reason thereof.

#### FORMAT OF PLAY

The Championship is 36-holes stroke play qualifying and match play. The schedule and format of the tournament will be as follows:

April 8, 2019 (Monday) 1st Qualifying Round (Stroke Play) April 9, 2019 (Tuesday) 2nd Qualifying Round (Stroke Play)

\* Only the top 16 male, top 16 female will qualify for the match play competition. Ties for the 1st and last qualifying slots for all categories will be resolved by sudden death play-off.

\* For purposes of determining places in the draw, ties in qualifying rounds other than those for the first and last qualifying place will be decided by the order in which scores are returned, with the first score to be returned receiving the lowest available number, etc. If it is impossible to determine the order in which scores are returned, ties are to be determined by a toss coin or by a blind draw.

## SIZE of the FIELD

a. The field will be limited to a maximum of 44 MENS and 20 LADIES.

b. In the event that the entries fall short or exceed of the aforesaid respective numbers, the Committee reserves the right to amend the eligibility requirements as they deem fit. In general, entries will be based on the entrants with the Lowest Handicap Index.

# ENTRY

- a. MEN'S & LADIES DIVISION The Entry Fee shall be Php3,000.00 for Filipino citizens and Php4,000.00 for foreign citizens.
- b. MID-AMATEUR OPEN DIVISION The Entry Fee shall be Php2,500.00 for Filipino citizens and Php3,500.00 for foreign citizens.
- c. CEBU COUNTRY CLUB MEMBER The Entry Fee shall be Php1,500.00
- d. Entries must be made on the Official Entry form and accompanied with the Entry Fee by cash or check.
- d. Entries must be received not later than April 5, 2019 (Friday), 12:00 pm.
- e. The Organizing Committee reserves the right to limit, accept or reject any entry without assigning any reason
- whatsoever. Late entries will be accepted at the discretion of the Organizing Committee.
  - e. Any WITHDRAWAL or CANCELLATION must be made before April 5, 2019 (Friday) as there will be NO refund of the Entry Fee after this date.

# PRACTICE ROUND

- a. Players will be allowed one (1) free practice round on April 5, 2019 (Friday) or
  - April 7, 2019 (Sunday after 1:30pm) provided they have registered and paid their entry fee.

## TEES

- a. Men's Division will tee off from the Blue Tees
- b. Ladies Division will tee off from the White Tees
- c. Mid-Amateur Open Division will tee off from the Blue Tees

## DRAW/PAIRINGS

a. The Draw/Pairings for the First and Second Rounds will be made by the Organizing Committee before the start of the Championship.

b. The Draw/Pairings for the Third and Final rounds will be based on scores of the previous Rounds.

## TIME OF STARTING

a. Players shall start at the time and order indicated in the DRAW. No substitution of players and changes of starting time shall be allowed after the DRAW has been made.

b. The ORGANIZING COMMITTEE reserves the right to change and alter the starting times without giving any reason.

#### WINNERS and PRIZES

- **a.** The following prizes will be awarded:
- I. Men's Division
  - Champion, 1st Runner-up & 2nd Runner-up

# II. Ladies Division

Champion, 1st Runner-up & 2nd Runner-up

# III. Mid-Amateur Open Division

Champion & Runner-up

# SUBMISSION of SCORECARD

- a. Players must check their cards in the Scoring Office and ensure that their scores are correct and be signed by their markers. Any doubtful point should be settled with the Organizing Committee before returning the Scorecard.
- b. Scorecard is deemed officially submitted once the player has left the scoring room (area).

# **DECISION OF TIES**

a. In the event of a tie or ties for the First place, the Champion shall be decided by a hole by hole play-off starting at Hole #1 until a winner is determined. The play-off will to determine the Champion only.

- b. All other ties will be decided by count back in the following order:
- \*. Last 18 holes (1st-18th);
- \*. Last 9 holes (10th-18th);
- \*. Last 6 holes (13th-18th)
- \*. Last 3 holes (16th-18th)
- \*. Last hole (18th)

# SUSPENSION OF PLAY FOR DANGEROUS SITUATION.

a. A suspension of play for a dangerous situation and the resumption of play shall be signaled using the host club's warning system.

b. All open practice areas shall be closed during suspension for a dangerous situation until the Organizing Committee has declared them open. Players who does not heed will be subject to disqualification.

## **USE OF DISTANCE MEASURING DEVICE.**

- a. For this Championship, a player may obtain distance information by use of a distance measuring device. If during a stipulated round, a player uses a distance- measuring device to gauge or measure other conditions that might affect his play (e.g. elevation changes, wind speed, etc.) The player is in breach of Rule - 4.3 for which the penalty is for disgualification.
- b. The use of rangefinders with wind and slope corrections are not permitted.

## **USE OF CADDIE**

a. The club has sufficient caddies and players must use the club's caddies, however, personal caddies may be used, provided they are not PROFESSIONALS and the player must pay the corresponding caddy fee to the Club for the caddy on deck.

#### **INSURANCE**

a. All players are required to have appropriate golfing insurance.

## PACE OF PLAY.

a. Each hole has been given a maximum completion time based upon the length and difficulty of the Hole. The maximum allotted time for completion of 18 holes will be available prior to the round.

b. The maximum allowed time allocated per shot is 40 seconds. The timing will start when the player has had sufficient time to reach his ball, it is his turn to play and he is able to play without interference or distraction.

- c. Penalty for Brach of Condition
- 1 bad time Player will be warned by the referee and told that further bad will be subject to penalty. Penalty of one (1) Stroke 2 bad time. 3 bad time. Further penalty of two (2) strokes. Disgualification. 4 bad time.

# **TOURNAMENT RULES OFFICIALS/REFEREES**

a. The Tournament Rules Officials/Referees' decision on all matters pertaining to the Rules of Golf is final.

## **COMPETITION CLOSED**

a. When the prizes are presented to the winners, the results of the competition are deemed officially announced and the competition is closed.

# **STANDARDS OF PLAYER CONDUCT (Rule 1-2)**

a. All players ARE EXPECTED TO PLAY IN THE SPIRIT OF THE GAME. There is no penalty under the Rules for failing to act accordingly, except that the Organizing Committee may disqualify a player for acting contrary to the spirit of the if it is established that the player has committed serious misconduct.

b. The following may be considered as serious breach of PLAYER CONDUCT:

. Continuous use of cellular phones during the round. Players will be warned accordingly by the Referee or by a Committee member.

- \*. Verbal abuse to a fellow competitor/official/staff.\*. Intentionally distracting or offending fellow competitor.
- \*. Causing unnecessary damage to the course or club property.
- \*. Any other action which may be considered to be breach of PLAYER CONDUCT.

ANY OF THE ABOVE SERIOUS BREACH of Conduct is subject to disqualification penalty.

#### SPECTATORS/COACHES/PARENTS

a. Spectators, coaches, and parents must remain on the cart path at all times. They must stay off the tees, general areas, putting greens, bunkers and penalty areas. They are allowed to use golf carts.

b. They should maintain a reasonable distance from the players to avoid the impression that they are giving advice or assisting the player in any way. They may approach the player for a moment to give clothing, food or beverage but should not have prolonged contact.

c. Those found to be violating these policies may be asked to leave the COURSE.
